**ABOUT THE LIST**  
This List ranks companies that are privately owned, at least 51 percent family-owned, and globally headquartered in Washington. To qualify, companies may be owned by two or more family members or spouses, owned by a family member with at least one relative employed full-time, owned by a family member after the business was inherited or bought from an earlier family generation, or specify another type of family control.

Information was obtained from firm representatives, company websites and Hoovers, a third-party business intelligence database. Information on The List supplied by individual companies through questionnaires could not be independently verified by the Puget Sound Business Journal. Only those that responded to our inquiries or had reliable information available elsewhere were listed. In case of ties, companies are listed alphabetically.

Sabey Corp. did not provide revenue for publication and reliable information was not available elsewhere. Oberto Brands was sold to a large Canadian food conglomerate in 2018 and QuoteWizard was sold to Lending Tree on Nov. 1, 2018.
